Accreditation fee All building consent applications will incur a council accreditation charge in addition to Council's building consent fees. This helps to cover the cost of maintaining our accreditation as Building Consent Authority. **\$45.00** per consent application

Simpli and GoGet The following charges are applicable to every building consent, in addition to the consent fees detailed below

Simpli portal fee	\$45.00 per consent application
GoGet administration fee	\$87.00 per consent application

All fees are indicative unless we identify them as "fixed". This means we may charge additional fees if necessary to cover the actual time involved and inspections required.

When the processing of your consent is complete, you will be invoiced for the applicable fees and levies payable. You will need to pay your levies and fees in full, prior to the consent being issued. Once the work is complete, if additional inspections or building officer time were required during the 'build', you will be invoiced for these fees and required to make payment, prior to the issue of your Code Compliance Certificate.
