# Annual Section 10A Dog Control Act 1996 Report 2023/2024

### PART 1 – Dog Control Policy and Practices

#### Dog Control in the District

During the 2023/2024 year, Council's Animal Control Team, through a joint service agreement with Rangitīkei District Council, delivered animal control services across a combined area of 7050km<sup>2</sup>. The team enforced the Dog Control Act 1996 and adhered to Council's Dog Control Policy 2019.

Comprising five Animal Control Officers, supported by the Manager Animal Control, the team operated 24/7 to respond to service requests and complaints within the timeframes specified in the Councils' Long Term Plans. Proactive efforts focused on identifying unregistered and wandering dogs and addressing complaints related to aggressive dog behaviour, including attacks.

A graduated enforcement approach was used for unregistered dogs, progressing from property inspections to verbal or written warnings, infringement notices, and impounding as a final measure.

#### **Hours of Operation**

Normal hours of operation are 8am – 5pm on weekdays. Animal Control Officers work on rostered shifts to enable 24-hour response to Priority One calls after hours, including weekends and public holidays. Priority One calls include dog attacks.

#### **Selected Owner Status**

Dog owners may apply for Selected Owner status which entitles them to a reduced annual registration fee. To qualify for this status owners must meet specific criteria. Council will assess applications based on the following factors:

- Whether property fencing is adequate.
- If the dog(s) have been neutered.
- The owner's compliance history with the Dog Control Act and Council bylaws, including any nuisance complaints.
- If dogs have been registered before the due date.
- Whether there is appropriate dog care, including kennel conditions (weatherproof, size, cleanliness, and sanitation).

Animal Control Officers will conduct property inspections of applicants to verify compliance with Selected Owner requirements.

#### **Menacing and Dangerous Dogs**

Animal Control maintain a list of all dogs classified as dangerous and menacing, this relating to classification by either the provisions of sections 31, 33A and/or 33C of the Dog Control Act 1996. Physical checks have occurred within this period to ensure that all dogs classified as menacing, regardless of the reason why, comply with the requirements of the classification.

There are 97 dogs classified as Menacing and 11 dogs classified as Dangerous for the 2023/2024 year. These are because of aggressive behaviour by the dog, or due to its breed.

#### Prohibited public places, dog on leash areas and dog exercise areas

There are specific areas within the Manawatū District Council area designated for exercise, lead only and prohibited areas.

Animal Control Officers approach any breaches of these requirements in an educational manner in the first instance.

#### Infringements

In 2023/2024 there were 70 infringements issued for the following offences

#### **Education relating to Dogs**

The Manawatū District Council is committed to promoting responsible dog ownership through education and support. A comprehensive dog education program, including a children's book that was published by our contractor, is delivered to local schools to foster safe and positive interactions with dogs.

Animal Control Officers provide valuable resources and guidance to dog owners, including advice on obedience training, behaviour management, and available training courses. The team has undertaken specialised training in canine psychology and behaviour to enhance these services.

A continued focus on dog education and behaviour support will improve dog ownership and community safety.
