I refer to your official information request dated 14 March 2025 for information on raised pedestrian crossings in the Tararua District.

The information you have requested is set out below.

Q1: When did you build your first raised pedestrian crossing, and why? (As opposed to a standard zebra crossing)

A1: Our first and only raised pedestrian crossing in the Tararua District was installed at Rawhiti Street in January 2024. There was a flat surface zebra crossing at this location in the past, but it was turned into a raised pedestrian crossing as part of the NZTA Road to Zero Safety drive. This crossing now performs two crucial tasks 1- to slow vehicles down approaching the pedestrian crossing and 2- to slow vehicles down approaching and exiting the roundabout.

Q2: How many have you built since?

A2: None – Rawhiti Street raised Pedestrian crossing is the only one in the Tararua District. There are other raised structures at roundabouts that are primarily speed bumps and should not be confused with or used as raised pedestrian crossings.

Q3: In the past 5 years, how many pedestrians have been injured on traditional zebra crossings in your area?

A3: We do not have any reported incidents related to pedestrian crossings.

Q4: In the past 5 years, how many pedestrians have been injured on raised pedestrian crossings in your area?

A4: We do not have any reported incidents related to pedestrian crossings.
